## Rule of 22

The Rule of 20 suggests bidding with distributional hands which lets us open the bidding more frequently. If we add our high card points to our length points and reach 20 we can open the hand, ie open a hand with 10 HCP plus two five card suits.

Several authors have suggested minor adjustments to this rule, taking defensive tricks into consideration.

The 4-3-2-1 point count system we all use to add up HCP undervalues aces and overvalues queens and jacks, therefore the Rule of 22 is considered a more reliable technique when evaluating the playing strength of a hand. The extra 2 comes from the required number of quick tricks, which are tricks that can be won if you end up defending.

## Rule of $\mathbf{2 0}$ Adjustments:

Positive features - add 1 point if the hand has:
At least 2 quick tricks
Two tens usefully combined with one or more higher honours in a 3 card or longer suit (eg AJ $10 \times$ or Q J 10, A 109 x )

Negative features - subtract 1 point if the hand has:
A singleton $K, Q$, or J
A doubleton KQ, KJ, QJ, Qx or Jx
An unguarded $Q$ or J (eg $Q x x$ or $x x$ )
No aces
Queens and Jacks contributing 50\% or more of the HCP

## QUICK TRICKS

## AK in the same suit =2

$A Q$ in the same suit $=1 \frac{1}{2}$
A or $K Q$ in the same suit =1
K with J or lower value $\operatorname{card}(\mathrm{s})=1 / 2$
therefore, we think of the Rule of 22 as The Rule of $20+2$ with the " 2 " an additional requirement.
Let's apply the Rule of 22 to some hands:
1ヶAQ974『83*KJ872~5
This hand has 10 HCP plus 10 cards in the two longest suits and also has 2 quick tricks with the AQ and KJ in the same suits so $20+2=22$ Open 1 s

2 (KQ K 8753 KJ952 5
Hand 2 meets the Rule of 20 with 10 HCP and 10 cards in two suits but it is lacking in the quick tricks department with only 1.5 ( one in spades and .5 in diamonds) Pass this hand

11 HCP plus 6 cards in the longest suit and 3 cards in the second longest suit $=20$ plus 2 quick tricks (AQ plus KJ) Open 14

This hand does have 12 HCP with 5 cards in one suit and 4 cards in another which $=21$.
The adjustment under the Rule of 22 would be -4 as it has no aces, doubletons KJ and Q5, and minor honours account for half the HCP. Therefore $21-4=17$ so this hand should not be opened under the Rule of 22.


Here is a board from the club recently
Declarer was East and under the Rule of 20 could open 14 with 10 HCP and 10 cards in two suits (which I did sadly = disaster)

However, applying the Rule of 22 this hand would be downgraded as it only has $11 / 2$ quick tricks, ie $K Q=1$ plus $K J=1 / 2$ so pass this hand. As you can see even with 15 HCP with West it makes almost nothing! (opening 1a means you will always end up in spades)

Once you apply the Rule of 22 to open, gauge your future bids on the actual strength of your hand, along with judgement based on what you learn as the auction progresses. But don't chicken out mid auction and pass partners forcing bid, opening the bidding obligates you to see that the bidding remains open, and continues normally.
