Rubens Advances

As you know, with the help of transfers you can describe many more hand types than with natural methods. The main reason for this is that you can use the same initial bid (the transfer) to cater for weak, intermediate and strong hands. In the 1970s, Jeff Rubens introduced the concept of using transfers in response to an overcall. Although this is one of the most significant bidding innovations, the idea is not popular outside of expert circles. Transfer Advances of Overcalls have one major advantage over just about every other convention ever devised: they do not take away a single natural bid. Rubens transfer advances however works part of the time depending on how much bidding room there is and it never costs.

Let us discuss the basics of Rubens advances. We would recommend that Rubens transfers are used only after partner makes a simple overcall over opponent's opening bid. LHO opens 1C, partner overcalls 1S and RHO passes ((1C) - 1S - Pass - ?). The following are your options:

- 1NT Natural, same as in standard methods.
- 2C Transfer to diamonds (can be weak, intermediate or strong)
- 2D Transfer to hearts (can be weak, intermediate or strong)
- 2H cue bid (instead of 2C cue bid in standard methods).
- 2S Normal raise.

In the above example we could transfer to both the remaining suit as we had the maximum space, which is not the case always. The following are the general principles to remember:

- All responses below cue bid of opponents suit are natural.
- All bids in NT are natural.
- Cue bid is a transfer to next-higher ranking suit. If that suit is the partner's suit then certainly the bidding is same as in standard methods.
- The bid of suit above opponents suit is transfer & the bid of suit below partner's suit is the Cue bid.
- The raises of partner's (overcaller's) suit are pre-emptive.
- Jump in opener's suit is splinter and jump in new suits can be played as fit jumps.

Overcaller's simple acceptance of transfer shows that he would have passed a non-forcing bid and denies extra values. The following are some more auctions:

(1C) – 1H – (Pass) – ?	(1D) – 2C – (Pass) – ?	(1S) – 2H – (Pass) – ?
1S = Natural, one round force	2D = Transfer to Heart	2S = Transfer to Club
1N = Natural	2H = Transfer to spade	2N = Natural
2C = Transfer to diamonds	2S = Cue bid	3C = Transfer to diamond
2D = Cue bid	2N = Natural	3D = Cue bid
	3C = Normal raise	3H = Normal raise

We would recommend this convention for serious partnerships only because if partner forgets the transfer, results can be disastrous. However the advantages of this convention will far out weigh the losses in the long run.
